LIHEAP - Department of Human Services

The LIHEAP program in your community determines if your household's income qualifies for the program. You must be a resident of the state of Pennsylvania and you must need financial assistance with home energy costs. *For households with more than eight people, add \$6,720 per additional person.

Pennsylvania Low Income Home Energy Assistance Program ...

- Income at or below 200%of the Federal Poverty Level
- Responsible for the main source of heat in the household o pay utility or fuel vendor directly; or pay indirectly through rent
- Residency in Pennsylvania

Income Guidelines. The LIHEAP statute establishes 150 percent of the poverty level as the maximum income level allowed in determining LIHEAP income eligibility, except where 60 percent of state median income is higher. Income eligibility criteria for LIHEAP may not be set lower than 110 percent of the poverty.

Learn About the Income Requirements for LIHEAP. Every state must set LIHEAP income guidelines each year according to the Department of Human Health Services Poverty Guidelines and State Median Estimates issued on the Federal Register. States must set a maximum income level based on household size and the federal poverty level.

The LIHEAP statute { (Section 2605 (b) (2) (B) or Assurance 2} says that to be eligible a household must have an income that does not exceed the greater of 150 percent of the federal poverty guideline (FPG) or 60 percent of the state median income (SMI) level.

First, the LIHEAP system compares your gross income and household size to the Federal Poverty Income Guidelines. If your income is equal to or below the guidelines, you could be eligible for a LIHEAP benefit. The amount of the benefit is determined based on income, the area where you live, type of fuel used, and the household size.

To be eligible for the Crisis Program, a household must: Be responsible for paying their primary or secondary heating source. Have a total household income at or below 150 percent of the Federal Poverty Income Guidelines (FPIG)

Page Content. PECO customers impacted by the COVID-19 pandemic may be eligible for up to \$800 through LIHEAP's Recovery Crisis Program. Customers with a past-due bill and a household income at/below 150% of the federal poverty income guidelines may be eligible. The LIHEAP Recovery Crisis program is open now and accepting applications until August 31, 2020, or until funds are gone.

However, LIHEAP grantees can change their LIHEAP income eligibility cut-off if they had originally set them below the federally permitted maximum—the greater of 150% of the Federal Poverty Guidelines or 60% State Median Income (SMI).

LIHEAP benefits are calculated on income, household size, the fuel type and the heating region where you live. You must include all people who live your home or apartment and their income. General Eligibility Requirements: Income at or below 150% of the Federal Poverty Level. Responsible for the main source of heat in the household (pay utility or fuel vendor directly; or indirectly through rent) Residency in Pennsylvania.

The Federal government establishes that the income limit for persons applying for LIHEAP be no lower than 110% of the Federal Poverty Level (FPL), yet no greater than 150% of the FPL. Within that range, states can choose a specific level.
